

I, Sonali Arora, Practicing Company Secretary was appointed as Scrutinizer by the Board of Directors in their meeting held on 14<sup>th</sup> January, 2020 for conducting the Postal Ballot and E-Voting process in respect of:

1. Special Resolution under section 180(1)(a) of the Companies Act, 2013 authorizing Board to create charge on assets/undertakings of the Company to secure borrowing.

Vide postal ballot notice dated 20<sup>th</sup> January, 2020 for conducting the voting process in fair and transparent manner. The Management of the Company is responsible for ensuring the compliances with the requirement of the Companies Act, 2013 and rules relating to the voting through electronic means and physical postal ballot forms on the resolution in the Postal Ballot Notice.

My responsibility as the scrutinizer for overseeing and reporting on the voting process is restricted to verifying and submitting my report on the votes cast 'in favour' or 'against' the resolution based on the postal ballot forms submitted by the shareholders of the Company and on the Company and on the reports generated from the system provided by NSDL, the authorized service provider of electronic voting facility to the shareholders of the Company.

- 1. In terms of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and administrative) Rules, 2014, the Company has issues a postal ballot notice dated 20<sup>th</sup> January, 2020 through:
  - a) Email to members (as on 10<sup>th</sup> January, 2020, being the cutoff date) whose email addresses are registered in the records of the depository participants viz. National Securities Depository Limited [NSDL] and Central Depository Services(India) Limited [CDSL] and;
  - b) Physical mode, along with the postage prepaid self addressed Business Reply Envelopesta other members who have not registered their email ids.
- 2. The voting through postal ballot and remote e-voting commenced from Tuesday, 2 2020 at 09.00 a.m. and end on Wednesday, 19<sup>th</sup> February, 2020 at 5.00 p.m.

- 3. The particulars of all the Postal Ballot/Electronic votes received from the members have been entered in the electronic register separately maintained for the purpose.
- 4. I have downloaded the date of e-voting after the E-voting module was disabled for e-voting by NSDL, by using scrutinizer's login on the NSDL e-voting website.
- 5. The sealed postal ballot forms received from the shareholders were kept under the safe custody of M/s MAS Services Limited, the Registrar and the Share Transfer Agent of the Company.
- 6. The Postal Ballot forms were scrutinized and the shareholding was matched / confirmed with the Register of Members of the Company /List of Beneficiaries as on 10<sup>th</sup> January, 2020, being the cut-off date provided by the Registrar and Share Transfer Agent of the Company.
- 7. All the Postal Bailot Forms and E-Votes received up to 5:00 P.M on Wednesday, 19<sup>th</sup> February, 2020 were under my scrutiny.
